- Midland International Airport Industrial Park Addition, Section 5, Midland, Midland County, Texas.
- iv. Discuss the purchase, exchange, lease or value of real property described as an approximate 374 acre tract of land out of Section 33, Block 40, T-1-S, T&P RR Co Survey, Midland County, Texas.
