10. Discuss and consider a presentation from Midland Development Corporation staff regarding the proposed Midland Development Corporation Small Business Assistance Program.

Director of Operations Sara Harris stated that similar small business programs were being implemented by development corporations across the state of Texas.

Executive Director John Trischitti stated that Mayor Payton's desire was to do something to assist small businesses, and there were dollars in the promotions fund that could be used. He explained that Sara Harris had a plan in place and that Second Vice Chair Lowery helped work out parameters to help small business during trying items. Businesses would have to meet requirements to keep funding. Reviewed eligibility requirements would include businesses located in the City limits, and headquartered in Midland or franchise wholly owned here. Executive Director Trischitti stated they were really trying to help our true small local businesses. Discussion ensured regarding the application process and requirements.

Director Lowery stated he had spoken with a local bank to see how they would feel about administering. If the MDC put up their own money it would be purely administrative, and the bank should be local and large enough to handle and ensure as many people know as possible.

11. Consider a resolution authorizing the adoption of the Midland Development Corporation Small Business Assistance Program; authorizing the Chairman and the Executive Director to take all action necessary for the implementation of the Program; and authorizing the Executive Director to execute all associated documents and agreements.

Director Pennington stated she would like a report of the details. Chairman Bownds added the caveats that the board would like to reconsider if additional funding is needed after the first one million dollars is expended, and that MDC staff should report ongoing progress to the MDC board.

Director Lowery moved to approve Resolution ED-357 authorizing the adoption of the Midland Development Corporation Small Business Assistance Program; authorizing the Chairman and the Executive Director to take all action necessary for the implementation of the Program; and authorizing the Executive Director to execute all associated documents and agreements; seconded by Director Simpson. The motion

carried by the following vote: AYE: Bownds, Lowery, Simpson, Pennington, Bedell and Sams. NAY: None. ABSTAIN: None. ABSENT: Gardaphe.

12. Receive and discuss a presentation regarding ongoing infrastructure partnerships between the City of Midland and the Midland Development Corporation.

Mr. Law gave an update on project updates and the procedures for new board members.

Mr. Law presented a slide show of the moving pieces and infrastructure of the City and time frames of projects and stated a lot had changed with the COVID-19 pandemic and the downturn in the price of oil.

He spoke on the limitations the City staff has and how the MDC helps with bringing in quicker answers. They are doing work to give the City Engineer the capacity so that when money becomes available the plans are there.

Director of Engineering Jose Ortiz stated that by having these conversations in advance and being proactive, they have been able to get projects done sooner. Having shelf ready plans helps collaboration between the City, County, TXDOT, and developers.

13. Receive and discuss the May 2020 monthly expenses from the Midland Development Corporation.

Sara Harris stated expenditures were down because of no staff travel and curtailed marketing due to the COVID-19 pandemic.

14. Receive and discuss the monthly economic development activity report from the Midland Development Corporation staff.

Gary Law stated the Spaceport Business Park was in the maintenance period, since the landscaping project had been completed. He added that the Avalon Drive extension plans were about 30% complete.

Sara Harris stated that the unemployment rate in the Midland MSA has reached a record high.

The Board excused observers at 11:25 a.m. and recessed into executive session.

1. Call meeting to order.

Chairman Bownds called the meeting to order at 10:01 a.m.

2. Consider a motion approving the minutes of the June 01, 2020, meeting of the Midland Development Corporation.

Director Pennington had questions on whether or not there had been an amended motion for Item 11, resolution authorizing the adoption of the Midland Development Corporation Small Business Assistance Program; authorizing the Chairman and the Executive Director to take all action necessary for the implementation of the Program; and authorizing the Executive Director to execute all associated documents and agreements. Director of Operations Sara Harris stated they would do a review of the audio for any corrections and bring the minutes back to the board for approval at the next meeting in August.

3. Consider a resolution approving the budget for the Midland Development Corporation's 2020-2021 Fiscal Year.

Executive Director John Trischitti explained these were interesting fiscal times and that there had been some challenging decisions to be made in the fiscal year 2021 budget.

He gave a brief overview of the budget packet and noted that one of the largest cuts in operating expenses was to eliminate the Director of Business Development position.

Sara Harris stated that there was a bottom line expenditure reduction of 18 percent compared to the fiscal year 2020 budget.

Director Pennington moved to approve Resolution ED-358 approving the budget for the Midland Development Corporation's 2020-2021 Fiscal Year; seconded by Director Simpson. The motion carried by the following vote: AYE: Bownds, Lowery, Simpson, Gardaphe, Pennington, Bedell and Sams. NAY: None. ABSTAIN: None. ABSENT: None

4. Consider a resolution authorizing the execution of an amendment to that certain economic development agreement between the Midland Development Corporation and Susie's South Forty Confections, Inc.

Sara Harris stated that the amendment provided accommodations for the new economic situation faced by Susie's South Forty Confections, and decreased the contractually-obligated number of new jobs and new payroll that the company must create, while also decreasing the incentive payable by the MDC.

Director Simpson moved to approve Resolution ED-359 authorizing the execution of an amendment to that certain economic development agreement between the Midland Development Corporation and Susie's South Forty Confections, Inc.; seconded by Director Gardaphe. The motion carried by the following vote: AYE: Bownds, Lowery, Simpson, Gardaphe, Pennington, Bedell and Sams. NAY: None. ABSTAIN: None. ABSENT: None

5. Receive and discuss the June 2020 monthly expenses from the Midland Development Corporation.

Sara Harris gave an overview of the June 2020 monthly expenses. She noted that economic development agreements between the City of Midland and the MDC that provided funds for the completion of the widening of SH 349, the construction of the bridge at Carver Street and Scharbauer Draw, and the city's Communications Ring had all been officially completed, and notes receivable owed by the City to the MDC had been expensed as a result of the project completions.

6. Receive and discuss the monthly economic development activity report from the Midland Development Corporation staff.

Director of Project Development Gary Law reported that MDC staff would be doing a detailed plant inspection this week for the Spaceport Business Park landscape project, and will be working with the contractor to replace any plants not surviving past this summer. He added that there was no change in the David Mims Parkway project, but that plans were in hand. He said that he continues to oversee development of roadway construction plans for the intersections of SH 158 and Briarwood, and SH 158 and Wadley, and that collaboration with TxDOT is ongoing. The Avalon extension had no notable changes, but several meetings on drainage concerns had taken place and will continue through fall. Finally, the abatement of the Western United Life Building continues to progress. Completion is expected by December 2020.

Sara Harris reported that the Small Business Assistance Program was open and that it had received 12 completed applications, of which 11 were ineligible, and one was pending determination of eligibility. John Trischitti stated a more formal report would be included in the next board packet.

Discussion ensured regarding soliciting help from local banks to encourage businesses to apply.

All the business at hand having been completed, Chairman Bownds adjourned the meeting at 10:49 a.m.

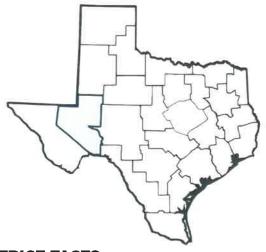

🖈 DISTRICT HIGHLIGHTS & PRIORITIES

The energy sector is a vital component of both the Texas and Odessa District economies. The district works strategically to invest resources not only to adapt infrastructure to support the energy sector's needs, but also to accommodate increasing demand on district roads and highways. The district works with energy sector and community partners to find solutions to the unique challenges of the industry. At any given time, the transportation infrastructure must be able to handle both a significant workforce influx and shifting traffic patterns.

Additionally, as oil production grows, energy sector traffic grows. This combination of factors leads to an increase in the amount of both industry and passenger traffic. The district's priorities focus on addressing those challenges through the use of Category 11 funding. This strategy allows for the district to focus Category 4 funding on rural connectivity projects. Additionally, Category 1 funding helps address maintenance issues created by increased traffic.

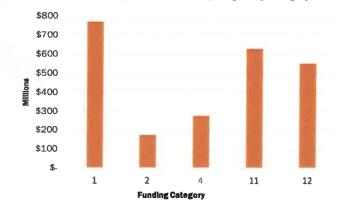

Odessa District: 2021 Planning Targets by Category



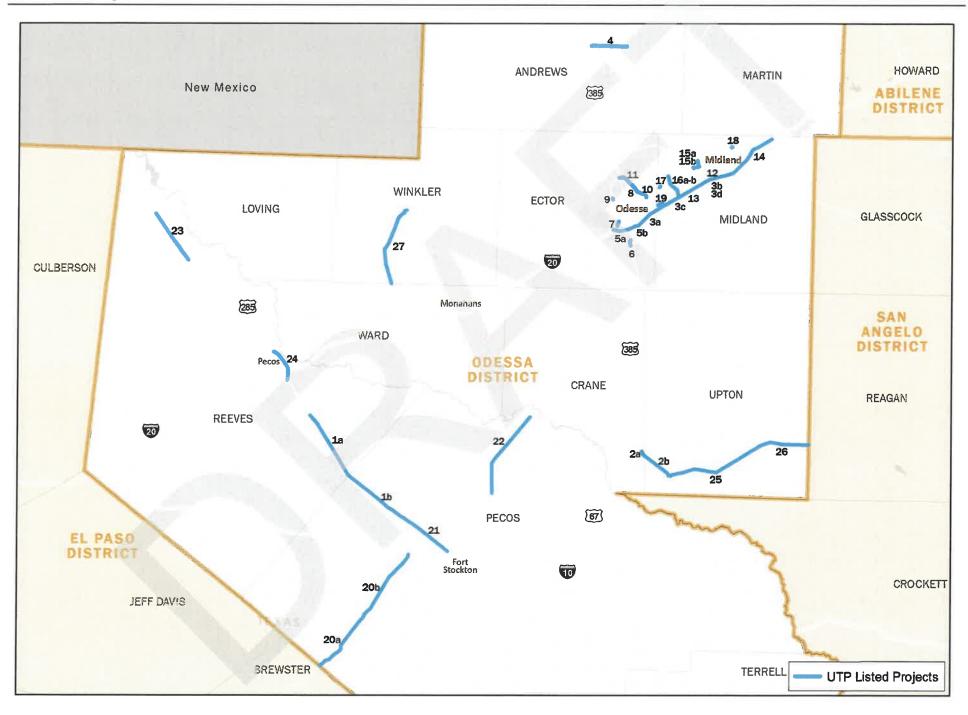

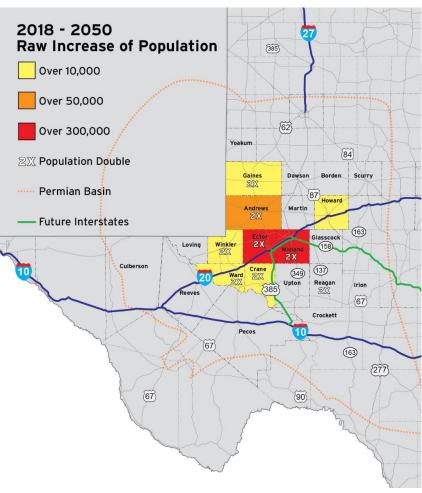




PERMIAN BASIN FREIGHT PLAN – 106,000 Daily Truck Trips





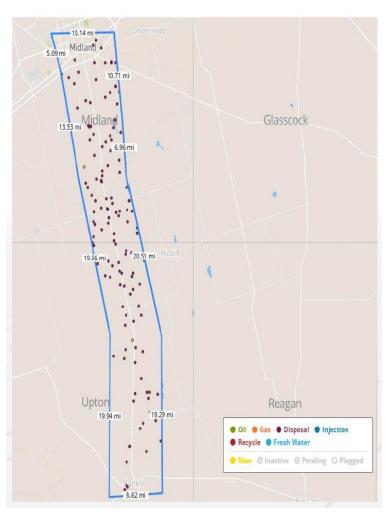


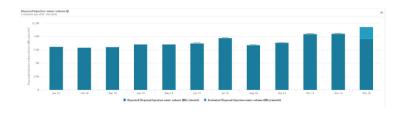


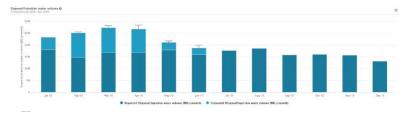


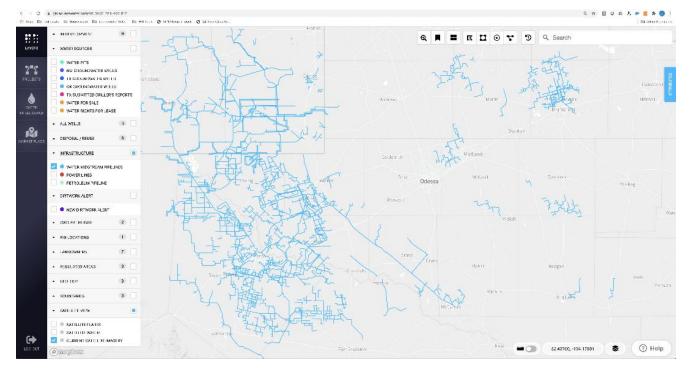

ECONOMIC DEVELOPMENT AGREEMENT BETWEEN THE MIDLAND DEVELOPMENT CORPORATION AND MOTRAN ALLIANCE, INC.

WHEREAS, Motran Alliance, Inc., submitted a Proposal to the Midland Development Corporation for economic development purposes and the funds for such Proposal can be appropriated by the Midland Development Corporation for fiscal year 2020-2021; and

WHEREAS, the primary purpose of Motran Alliance, Inc., is to raise funds for and improve the infrastructure of the Permian Basin area; and

WHEREAS, such activities will create the groundwork for developing new and expanded enterprises in the Midland/Odessa area; and

WHEREAS, the parties have agreed on the terms and conditions and have set forth such terms and conditions in this Agreement;

NOW, THEREFORE, the Midland Development Corporation ("MDC") and Motran Alliance, Inc. ("MOTRAN"), do hereby contract and agree as follows:

I. ECONOMIC DEVELOPMENT PROGRAM

MOTRAN shall provide the economic development services as provided in **Exhibit B**, which attached hereto and incorporated herein for all purposes. Said services shall be referred to herein as the "Economic Development Program."

II. FUNDING

MDC shall pay to MOTRAN the total sum of One Hundred Thirty-Seven Thousand Dollars (\$137,000.00), for the 2020-2021 MDC fiscal year. Said funds shall be used solely for the purpose of conducting the Economic Development Program, as delineated in **Exhibit B**. MDC shall dispense funds to MOTRAN by paying one-half of the total on or before December 1, 2020, and one-half on or before April 1, 2021. It is understood and agreed that MOTRAN will obtain any other necessary

Exhibit A

funds for completion of the Economic Development Program from other sources. MOTRAN may perform services that are not eligible for expenditure of funds by MDC but the percentage of Economic Development Corporation funds received must not exceed the percentage of eligible services performed by MOTRAN.

III. BUDGET AND FINANCIAL REPORTING

MOTRAN shall comply with the budget showing the revenues and expenses, a copy of which is attached as **Exhibit A**, to be received and incurred during the term of this Agreement. The hereinafter-required financial reports shall, in each case, show the relationship of actual expenses to the authorized expenses shown in said budget.

On or before the 25th day of each month during the term of this Agreement, MOTRAN shall submit a report showing an accounting of all funds received and expended during the preceding month to MDC. MOTRAN shall file the same with the City Secretary of the City of Midland. Said report shall also show the cumulative expenses and revenues for the preceding month together with all prior months covered by this Agreement.

MOTRAN shall maintain complete and accurate financial records of each expenditure of Economic Development Program funds made by it. The general method of financial record keeping and reporting proposed by MOTRAN to be used in complying with the requirements of this Agreement shall be submitted to and approved by MDC. The sufficiency of detail of any activity or financial report required by this Agreement shall be determined by MDC. All of MOTRAN's records pertaining and related to the activities and funds under the Agreement shall be available for inspection by MDC or MDC's representatives at any time during MOTRAN's normal office hours. The revenue provided by MDC under this Agreement must be maintained by MOTRAN in a separate account established for that purpose and may not be comingled with any other money or maintained in any other account.

IV. INFORMAL REPORTING

The Activity Reporting Requirements outlined in <u>Article V</u> are for the purpose of providing information to meet the basic exchange of information. However, in order to (i) be efficient in the use of economic development funds; (ii) compete in the open market for jobs; (iii) respond to issues and economic development opportunities in a timely manner; (iv) make decisions regarding goals, objectives, and priorities; and (v) foster the necessary teamwork between MDC and MOTRAN, it is necessary to plan and implement certain informal reporting and interactions that may occur from time to time. For these purposes, the parties agree to engage in certain interactions and interoffice communications as follows:

- MOTRAN shall meet with those persons designated by MDC to develop a plan when decisions need to be made regarding negotiations or strategy; and
- MOTRAN will meet with the MDC whenever necessary and also develop and distribute, in writing or by oral presentation, reports when needed over and above the requirement contained in <u>Article V</u>.

V. ACTIVITY REPORTING REQUIREMENTS

MOTRAN shall provide quarterly activity reports, in writing, to MDC and the City Secretary of Midland that will provide a current status report. These reports shall provide hard data when available. These reports shall constitute the necessary activity reporting requirements under this Agreement.

VI. AUDIT

In addition to the reporting requirements contained herein, a certified audit of the funds and activities of such Economic Development Program shall be made annually. The costs of making the audit shall be paid by MOTRAN; provided, however, that MOTRAN may use MDC funds for this purpose. The auditors shall have access to and the right to examine all records and accounts directly

related to the Economic Development Program and such other MOTRAN records and accounts as may be reasonably necessary to conduct and complete the audit of the Economic Development Program funds.

VII. INDEPENDENT CONTRACTOR

It is expressly understood and agreed that as to any and all of the services tendered by MOTRAN in conducting the Economic Development Program under this contract, MOTRAN shall be considered an independent contractor insofar as its relationship to MDC. Accordingly, the officers and employees of MOTRAN used or involved in the Economic Development Program under this Agreement shall not be considered, for any purpose, to be the officers and employees of MDC.

It is expressly understood and agreed that MOTRAN shall perform all work and services described herein as an independent contractor and not as an officer, agent, servant or employee of MDC; that MOTRAN shall have exclusive control of and the exclusive right to control the details of the services and work performed hereunder, and all persons performing the same; and shall be solely responsible for the acts and omissions of its officers, agents, employees, contractors and subcontractors; that the doctrine of respondeat superior shall not apply as between MDC and MOTRAN, its officers, agents, employees, contractors and subcontractors; and that nothing herein shall be construed as creating a partnership or joint enterprise between MDC and MOTRAN. No person performing any of the work and services described hereunder shall be considered an officer, agent, servant or employee of MDC. Further, it is specifically understood and agreed that nothing in this Agreement is intended or shall be construed as creating a "Community of Pecuniary Interest" or "An Equal Right of Control." MOTRAN shall be an independent contractor under this Agreement and shall assume all the rights, obligations and liabilities, applicable to MOTRAN as such independent contractor hereunder. MDC does not have the right to control the means, methods or details of MOTRAN's work. MDC does not have the power to direct the order in

which MOTRAN's work should be done. MOTRAN shall assume exclusive responsibility for the work hereunder. MOTRAN is entirely free to do the work in its own way.

VIII. AGREEMENT PERIOD

This Agreement shall become effective on August 12, 2020, and shall terminate on September 30, 2021. If MOTRAN violates the terms or conditions of this Agreement, or fails to provide the agreed services, MDC may terminate this Agreement under the conditions pursuant to this Article. MDC shall provide written notice of the violations or failures to MOTRAN. MOTRAN shall have thirty (30) days to cure the violations or failures or to file a written response with MDC. If MOTRAN fails to cure or to file a written response within such 30-day period, MDC may terminate this Agreement immediately. If a written response is filed, MDC shall set a hearing before MDC's Board of Directors and provide notice to MOTRAN. After consideration of the response and the testimony at the hearing, MDC may declare if there has or has not occurred the stated violations or failures. If the Board finds that such violations or failures have occurred, it shall give MOTRAN thirty (30) days' written notice and an opportunity to cure. If not cured within such period, MDC may terminate this Agreement immediately.

IX. CIVIL RIGHTS

MOTRAN agrees that, as to all its programs and activities, it will not discriminate against any person on the basis of race, color, national original, sex or disability.

X. INDEMNITY

MOTRAN SHALL INDEMNIFY AND HOLD HARMLESS AND DEFEND MDC

AND ALL OF MDC'S OFFICERS, AGENTS AND EMPLOYEES FROM ALL SUITS,

ACTIONS, CLAIMS, DAMAGES, PERSONAL INJURIES, PROPERTY DAMAGE,

LOSSES, AND EXPENSE OF ANY CHARACTER WHATSOEVER INCLUDING

REASONABLE ATTORNEY'S FEES, BROUGHT FOR OR ON ACCOUNT OF ANY

INJURIES OR DAMAGES RECEIVED OR SUSTAINED BY ANY PERSON OR PERSONS OR PROPERTY, ON ACCOUNT OF ANY NEGLIGENT ACT OF MOTRAN, MOTRAN'S OFFICERS, AGENTS AND EMPLOYEES, WHETHER SUCH NEGLIGENT ACT WAS THE SOLE PROXIMATE CAUSE OF THE INJURY OR DAMAGE OR A PROXIMATE CAUSE JOINTLY AND CONCURRENTLY WITH MOTRAN OR MOTRAN'S EMPLOYEES, AGENTS OR SUBCONTRACTORS NEGLIGENCE, IN THE EXECUTION, SUPERVISION AND OPERATIONS GROWING OUT OF OR IN ANY WAY CONNECTED WITH THE PERFORMANCE OF THIS AGREEMENT, AND MOTRAN WILL BE REQUIRED TO PAY ANY JUDGMENT WITH COSTS WHICH MAY BE OBTAINED AGAINST MDC OR ANY OF ITS OFFICERS, AGENTS OR EMPLOYEES, INCLUDING ATTORNEY'S FEES.

XI. EXCESS MDC FUNDS

Any funds paid by MDC to MOTRAN pursuant to this Agreement that are not expended by the end of the term of this Agreement shall be refunded to MDC within thirty (30) days after the end of the term of this Agreement, unless MOTRAN provides MDC with written notice as to the funds that have not been expended but have been committed, and such commitment is supported by contracts or other written documentation.

XII. PROPERTY

Any records and documents that are developed for the purpose of accomplishing services on behalf of MDC by MOTRAN, and necessary to continue to provide such services, or to show the rights or responsibilities of MDC, shall be the joint property of MDC and MOTRAN with equal rights of use and access.

XIII. PROJECT

The parties agree that this Agreement is an eligible "Project" as defined in Chapter 501 of the Texas Local Government Code, as amended.

XIV. ASSIGNMENT

The parties hereto shall not assign or subcontract this Agreement, in whole or in part, any such assignment or subcontract being void.

XV. NOTICE

Any notice or report given under the provisions of this Agreement shall, unless otherwise provided herein, be in writing and shall be either delivered via email or sent by United States Mail:

XVI. SEVERABILITY

This Agreement shall be construed in accordance with the laws of the State of Texas. If any clause or provision of this Agreement is held to be illegal, invalid, or unenforceable under present or future laws effective during the term hereof, then it is the intention of the parties hereto that the remainder of this Agreement shall not be affected thereby and that, in lieu of each clause or provision that is illegal, invalid or unenforceable, there be added as a part of this Agreement a clause or provision as similar in meaning to such illegal, invalid or unenforceable clause or provision as may be possible and be legal, valid and enforceable.

XVII. ALTERATION

This Agreement may not be altered, changed or amended, except by a written instrument signed by both parties hereto.

XVIII. ENTIRE AGREEMENT AND BINDING EFFECT

This Agreement constitutes the entire agreement between MDC and MOTRAN. No prior written or contemporaneous oral promises or representations shall be binding. The provisions of this Agreement shall be binding upon and inure to the benefit of the successors and assigns of the parties.

XIX. GOVERNING LAW AND VENUE

This Agreement shall be governed by the laws of the State of Texas. All performance and payment made pursuant to this Agreement shall be deemed to have occurred in Midland County, Texas. The obligations and undertakings of each of the parties to this Agreement shall be deemed to have occurred in Midland County, Texas. Exclusive venue for any claims, suits or any other action arising from or connected in any way to this Agreement or the performance of this Agreement shall be in Midland County, Texas.

XX. COMPLIANCE WITH LAWS

In the payment and employment of people to serve as employees pursuant to this Agreement, MOTRAN shall comply with all federal, state and local laws, rules, regulations and ordinances with respect to payment of minimum wages. MOTRAN shall not discriminate against people on the basis of race, sex, age, religion, national origin, or mental or physical disability in the application, hiring, termination, evaluation, or compensation of people assigned to work under this Agreement, and shall further comply with all laws, rules and regulations prohibiting such discrimination including but not limited to, the Civil Rights Act of 1964, the Civil Rights Act of 1991, the Age Discrimination in Employment Act, and the Americans With Disabilities

XXI. GOVERNMENTAL IMMUNITY

By executing this Agreement MDC is not waiving its right of governmental immunity.

MDC is not granting consent to be sued by legislative resolution or action. THERE IS NO

WAIVER OF GOVERNMENTAL IMMUNITY.

XXII. ATTORNEY FEES

BY EXECUTING THIS AGREEMENT, MOTRAN AGREES TO WAIVE AND DOES HEREBY WAIVE ANY CLAIM IT HAS OR MAY HAVE AGAINST MDC, REGARDING THE AWARD OF ATTORNEY'S FEES THAT ARE IN ANY WAY RELATED TO THE AGREEMENT, OR THE CONSTRUCTION, INTERPRETATION OR BREACH OF THE AGREEMENT. MOTRAN SPECIFICALLY AGREES THAT IF MOTRAN BRINGS OR COMMENCES ANY LEGAL ACTION OR PROCEEDING RELATED TO THIS AGREEMENT, THE CONSTRUCTION, INTERPRETATION, VALIDITY OR BREACH OF THIS AGREEMENT, INCLUDING BUT NOT LIMITED TO ANY ACTION PURSUANT TO THE PROVISIONS OF THE TEXAS UNIFORM DECLARATORY JUDGMENTS ACT (TEXAS CIVIL PRACTICE AND REMEDIES CODE SECTION 37.001, ET SEQ., AS AMENDED), MOTRAN AGREES TO WAIVE AND RELINQUISH ANY AND ALL RIGHTS TO THE RECOVERY OF ATTORNEY'S FEES TO WHICH MOTRAN MIGHT OTHERWISE BEENTITLED.

MOTRAN AGREES THAT THIS IS THE INTENTIONAL RELINQUISHMENT OF A PRESENTLY EXISTING KNOWN RIGHT. MOTRAN ACKNOWLEDGES THAT IT UNDERSTANDS ALL TERMS AND CONDITIONS OF THE AGREEMENT.

BY EXECUTION OF THE AGREEMENT MOTRAN HEREBY REPRESENTS AND WARRANTS TO MDC THAT MOTRAN HAS READ AND UNDERSTOOD THE AGREEMENT.

XXIII. RELEASE

NOTWITHSTANDING ANY OTHER PROVISION HEREIN, MOTRAN HEREBY RELEASES, ACQUITS, RELINQUISHES AND FOREVER DISCHARGES MDC, MDC'S EMPLOYEES AND OFFICERS, FROM ANY AND ALL DEMANDS CLAIMS OR CAUSES OF ACTION OF ANY KIND WHATSOEVER THAT MOTRAN HAS OR MIGHT HAVE IN THE FUTURE, INCLUDING BUT NOT LIMITED TO BREACH OF AGREEMENT, QUANTUM MERUIT, CLAIMS UNDER THE DUE PROCESS AND TAKINGS CLAUSES OF THE TEXAS AND UNITED STATES CONSTITUTIONS, TORT CLAIMS, OR MDC'S NEGLIGENCE.

XXIV. THIRD-PARTY BENEFICIARY

MDC's approval of this Agreement does not create a third-party beneficiary. There is no third-party beneficiary to this Agreement. No person or entity who is not a party to this Agreement shall have any third-party beneficiary or other rights hereunder.

The Midland Development Corporation seeks to provide the infrastructure to support an aggressive commitment to make Midland competitive for economic development. MOTRAN employs an executive director and associated staff whose primary duties include working with national, state, regional, and local entities, as well as, private businesses to provide additional investment in area infrastructure, establishing the La Entrada al Pacifico as a premier trade corridor to help further the economic opportunities presented to this area with regard to international trade, working to improve transportation infrastructure in the region, development of links between Interstates 14 and 27 and the Midland-Odessa area, and strategies to leverage local efforts for additional state and federal highway dollars.

It is for this purpose that the Midland Development Corporation agrees to provide partial funding for MOTRAN to employ necessary staff and assist in performing the following duties:

- Organize and manage the international public policy initiative and all advocacy efforts;
- Organize and manage intergovernmental relations including committee organization and international organizations;
- Direct and participate in fund raising and public relations including direct marketing, web site development membership development and public speaking engagements;
- Direct and participate in research and production of technical and economic reports;
- Serve as the representative of the organization, both nationally and internationally;
- Draft corporate documents; and
- Perform related duties as directed, including seeking additional transportation funding from federal, state, and private sources for purposes of infrastructure development, and forging and organizing regional partnerships to accomplish area and regional infrastructure goals.

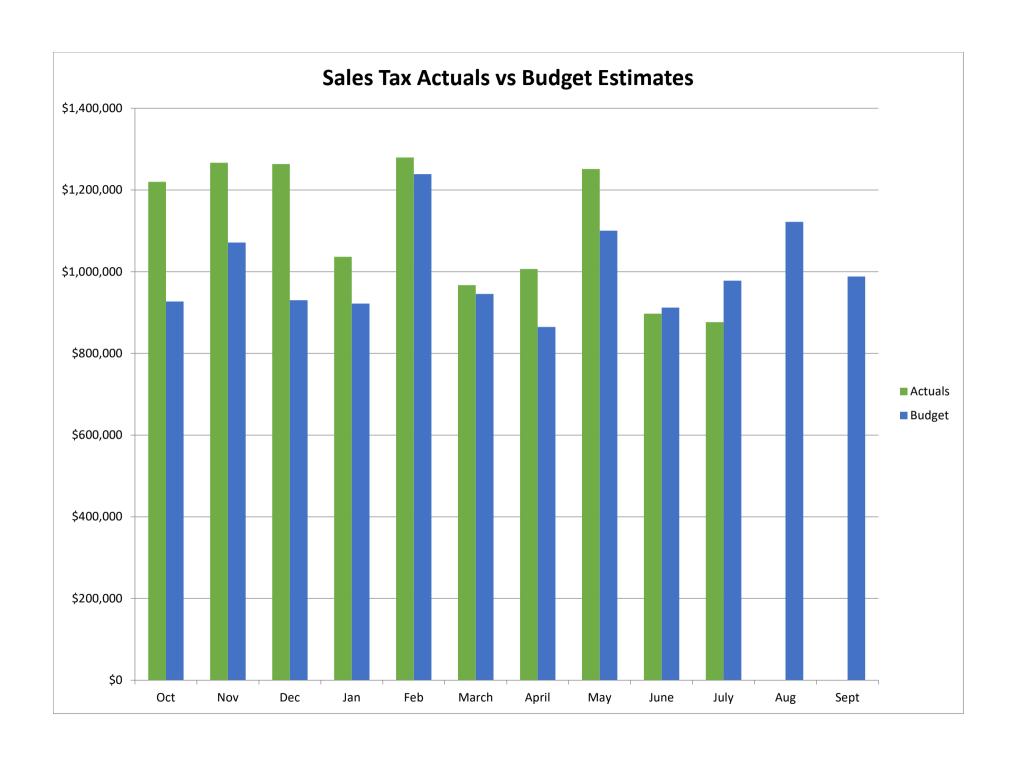

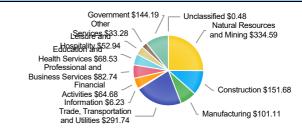
Historical Unemployment Rates



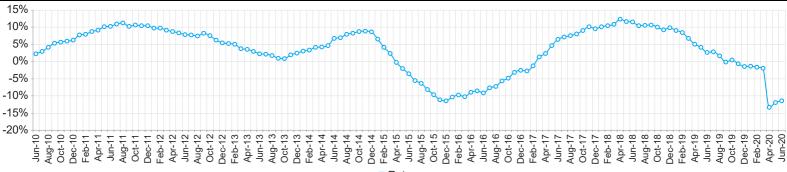
Employment by Size Class (4th Quarter 2019)



Wages by Industry (in millions) (4th Quarter 2019)



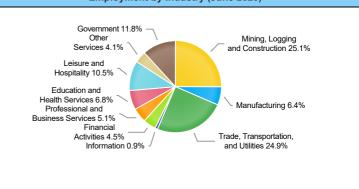
Annual Growth Rate Total Non-agricultural employment

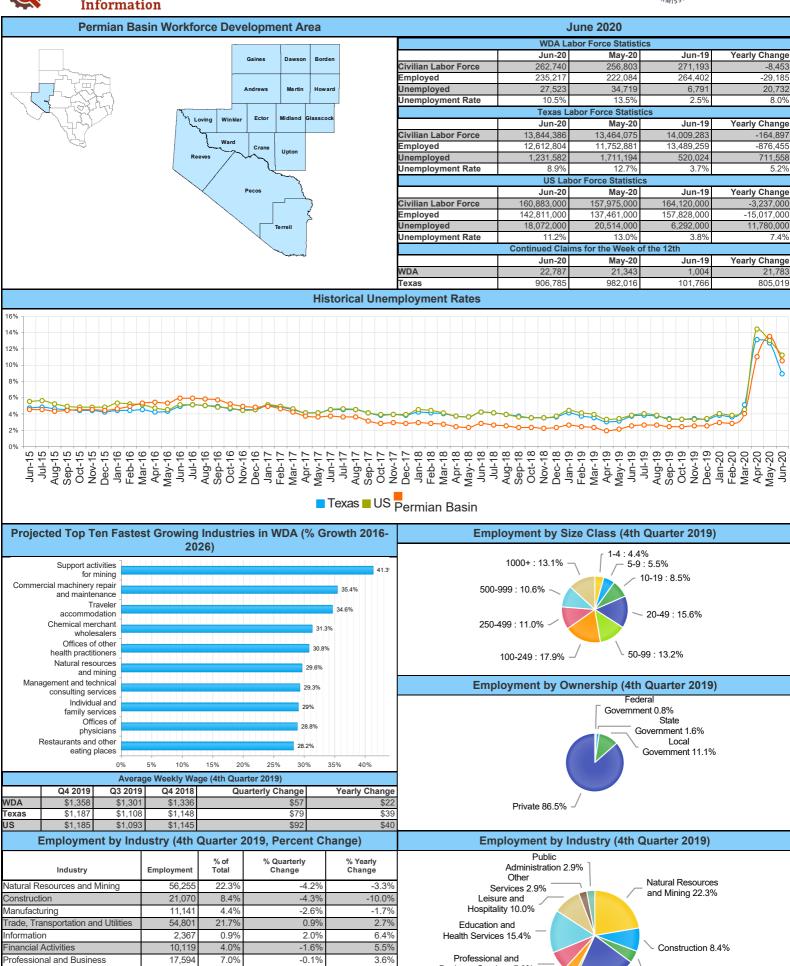
